A RESOLUTION OF THE CITY COMMISSION OF THE CITY HOLLYWOOD. FLORIDA. **APPROVING** ALLOCATION OF UP TO 39 ADDITIONAL BONUS HOTEL DENSITY ROOMS FROM THE "HOLLYWOOD BEACH HOTEL ROOM POOL" PURSUANT TO THE CITY'S COMPREHENSIVE PLAN TO FACILITATE CONSTRUCTION OF Α 349 ROOM HOTEL. PUBLIC/PRIVATE **PARKING** GARAGE AND OTHER AMENITIES FOR THE MARGARITAVILLE HOLLYWOOD BEACH RESORT PROJECT AS MORE SPECIFICALLY DESCRIBED IN THE ATTACHED EXHIBIT "A": AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City's Land Use and Coastal Elements of the Comprehensive Plan established the allocation of additional hotel bonus rooms from the "Hollywood Beach Hotel Room Pool" ("Pool"); and

WHEREAS, in accordance with the Pool, hotels and motels located in the Central Beach Area with a General Business land use shall not exceed 50 hotel rooms per acre (a maximum of 100 rooms per acre with allocation of rooms from the Pool); and

WHEREAS, the Pool currently consists of 664 bonus hotel density rooms; and

WHEREAS, on November 18, 2010, the Planning and Zoning Board, acting as the Local Planning Agency, and the Development Review Board held a duly noticed public hearing to review applications 10-F-59/10-DPV-59 submitted by Margaritaville Hollywood Beach Resort, LLC ("Applicant") which included the allocation of up to 39 rooms from the Pool, a Variance, Design Review and a recommendation for Site Plan Approval; and

WHEREAS, the Director of Planning & Development Services, following an analysis of the application and its associated documents, determined that the proposed allocation of up to 39 bonus hotel density rooms is consistent with the Comprehensive Plan and City-Wide Master Plan, and therefore recommended it be approved with the following conditions:

- (1) The allocation of up to an additional 39 bonus hotel room density rooms from the "Hollywood Beach Hotel Room Pool" shall remain valid for as long as the Site Plan approved by the City Commission pursuant to Resolution Number R-2010-364 is valid:
- (2) In the event that the Applicant has not used all of the 39 rooms allocated prior to the Certificate of Occupancy (C/O), the remaining balance of unused rooms will automatically revert back to the "Hollywood Beach Hotel Room Pool"; and

WHEREAS, upon hearing the aforementioned application, the Planning and Zoning Board, acting as the City's Local Planning Agency, has forwarded a unanimous recommendation of approval with the aforementioned conditions to the City Commission; and

WHEREAS, if such allocation is approved by the City Commission, the Pool will have 625 bonus hotel density rooms remaining; and

WHEREAS, the City Commission has reviewed the Applicant's request for an allocation of up to 39 bonus hotel density rooms from the Pool in accordance with the City's Comprehensive Plan and has determined that such allocation should be approved;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the allocation of up to an additional 39 bonus hotel density rooms from the "Hollywood Beach Hotel Room Pool" is hereby approved with the following conditions:

- (1) The allocation of up to an additional 39 bonus hotel room density rooms from the "Hollywood Beach Hotel Room Pool" shall remain valid for as long as the Site Plan approved by the City Commission pursuant to Resolution Number R-2010-364 is valid.
- (2) In the event that the Applicant has not used all of the 39 rooms allocated prior to the Certificate of Occupancy (C/O), the remaining balance of unused rooms will automatically revert back to the "Hollywood Beach Hotel Room Pool".


