### **Death Investigation Update #6**

**Date:** September 29, 2017 Update as of 9:30 a.m.

**Location:** 1200 N. 35<sup>th</sup> Avenue, Hollywood, Florida

Hollywood, FL – This is an update on the criminal investigation into the circumstances that led to multiple deaths at The Rehabilitation Center at Hollywood Hills at 1200 N. 35<sup>th</sup> Avenue in Hollywood.

A twelfth patient is now confirmed dead. The patient died on Thursday, September 28, 2017. The Hollywood Police Department is treating all deaths from this facility as part of the criminal investigation, until otherwise advised by the Broward County Office of Medical Examiner and Trauma Services.

Family members of patients who were evacuated from The Rehabilitation Center at Hollywood Hills to area assisted living facilities, nursing homes or hospice centers are being asked to call Hollywood Police Department Investigators at 954.967.4411 during normal business hours, Monday through Friday from 9:00 a.m. to 5:00 p.m. Afterhours, they are being asked to call 954.967.4435.
