

ORDINANCE NO. O-2013-20

AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING CHAPTER 52 OF THE CODE OF ORDINANCES TITLED "SEWER USE" TO EXTEND UNTIL SEPTEMBER 30, 2019 THE FY2014 SEWER RATE STRUCTURE AND BASE CHARGE.

WHEREAS, the City of Hollywood's Department of Public Utilities provides the critical role of collecting, treating and disposing of wastewater within the City of Hollywood and for six (6) surrounding communities, through its Southern Regional Wastewater Treatment Plant; and

WHEREAS, it is essential for the proper planning to take place in order to provide reliable wastewater services, and

WHEREAS, the City of Hollywood has begun implementation of the comprehensive Wastewater Master Plan which serves as a primary planning tool to meet regulatory requirements and address critical asset renewal and replacement needs; and

WHEREAS, the Wastewater Master Plan identified critical wastewater infrastructure assets that are well beyond their useful life which may pose public health and safety risks if not addressed properly; and

WHEREAS, the rate study proposed no rate increases for FY2015 through FY2019; and

WHEREAS, staff recommends that the City Commission amend Chapter 52 of the code of Ordinances to maintain the existing FY2014 wastewater rate structure and base charge through FY2019;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That Chapter 52 of the Code of Ordinances is hereby amended to read as follows:

(K) Commencing on October 1, 2019 2014 and continuing on October 1 of each year thereafter, a utility price index adjustment, which corresponds to the price index established, on or before March 31 of each year, by the Florida Public Service Commission pursuant to F.S. § 367.081 (4)(a), shall be applied to the base charge and flow rate then in effect.

AN ORDINANCE AMENDING CHAPTER 52 OF THE CODE OF ORDINANCES TITLED "SEWER USE" TO EXTEND UNTIL SEPTEMBER 30, 2019 THE FY2014 SEWER RATE STRUCTURE AND BASE CHARGE.

Section 2: That it is the intention of the City Commission that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of the City of Hollywood, Florida, and the provisions of this ordinance maybe renumbered to accomplish such intention.

Section 3: That if any word, phrase, clause, subsection or section of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of any remaining portions of this ordinance.

Section 4: That all sections or parts of sections of the Code of Ordinances, all ordinances or parts of ordinances, and all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed to the extent of such conflict.

Section 5: That this ordinance shall be in full force and effect immediately upon its passage and adoption.


